
## INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying statements of financial position of Sudanese Community and Women's Services Center (a nonprofit organization) as of December 31, 2009, and the related statements of activities, functional expenses, and cash flows for the year then ended. These financial statements are the responsibility of the Organization's management. Our responsibility is to express an opinion on these financial statements based on our audit.

**NOTE A—NATURE OF ACTIVITIES AND SIGNIFICANT ACCOUNTING POLICIES**

Nature of Activities

The Sudanese Community and Women's Services Center (the Center) is a Tennessee not-for-profit corporation dedicated to empowering refugees and immigrants who have resettled in Middle Tennessee. The Center does this by providing direct social services and educational programs in the following areas:

- Adult education – The Center provides classes in the English language, citizenship, GED, parenting and sewing.
- Career development – The Center provides assistance with resume writing, area job identification, vocational training, application writing, and referral services.
- Social adjustment - The Center provides immigration assistance, interpretation, referral services, and consultation services.
- Emergency services - The Center provides provision of food, clothing and shelter, as well as referrals to legal and family support services.
- Youth development - The Center provides one-on-one tutoring, leadership development, civic engagement, career and educational preparedness, and sports and musical experiences.
- Health and nutrition services - The Center provides classes and seminars on nutrition, disease prevention, child development, mental health, and healthy lifestyles.

Basis of Accounting

To date, the Center has utilized the cash basis of accounting for its 990 EZ filings. However, the Center prepared its results for the 12 months ending December 31, 2009 on an accrual basis in order to permit a more accurate analysis of operations. Since a majority of the Center's income includes cost reimbursements, the Center wished to see revenues and expenses matched in the same period on a donor by donor basis. Thus the Center switched internally to reporting on an accrual basis effective January 1, 2009.

Contributed Services

During the year ended December 31, 2009 the value of contributed services meeting the requirements for recognition in the financial statements was not material and has not been recorded.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Property and Equipment

It is the Organization's policy to capitalize property and equipment at cost. Maintenance and ordinary repairs are expensed. Donations of property and equipment are recorded as contributions at their estimated fair value. Such donations are reported as unrestricted contributions unless the donor has restricted the donated asset to a specific purpose. Assets donated with explicit restrictions regarding their use and contributions of cash that must be used to acquire property and equipment are reported as restricted contributions. Absent donor stipulations regarding how long those donated assets must be maintained, the Organization reports expirations of donor restrictions when the donated or acquired assets are placed in service as instructed by the donor. The Organization reclassifies temporarily restricted net assets to unrestricted net assets at that time. Property and equipment are depreciated using the straight-line method.

Period of Audit

The Center's fiscal year ends March 31. As a major grantor to the Center, the Tennessee Office of Refugees (TOR) requires an annual audit as a condition for receiving ongoing funding. The present audit is undertaken to satisfy this TOR requirement. Since the TOR grant runs on a calendar year basis, this audit covers the year ending December 31, 2009. This is the first audit in the Center's history.

The Board of Directors met in January 2010 and voted to change the fiscal year end to December 31.

Income Taxes

The Organization is a not-for-profit organization that is exempt from income taxes under Section 501(c) (3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation.

Cash and Cash Equivalents

For purposes of the statements of cash flows, the Organization considers funds held in the operational checking accounts and the savings accounts to be cash equivalents.

**NOTE B—ACCOUNTS RECEIVABLE**

All receivables outstanding at December 31, 2009 were for grant reimbursement requests. Management believes them to be 100 percent collectible.

Depreciation expense for 2009 was \$3,170.

**NOTE D – DESCRIPTION OF LEASING ARRANGEMENTS**

The Center occupies a suite of office-type space comprised of approximately 1,900 square feet located at 3221 Nolensville Pike, Suite 103, Nashville, Tennessee 37211. The space includes a lobby, two classrooms, three administrative offices, a child care area, a computer lab, break room, and restrooms.

The Center leases the space for \$1,200 per month which includes heating/cooling, water/sewer, and trash service. The Center pays separately for its telephone and Internet services.

The Center's current lease was signed on January 30, 2009. The lease period began February 1, 2009 and expires on January 31, 2011. There is a \$150 deposit. The lease requires the Center to replace the carpet upon leaving and the Center estimates this will cost approximately \$4,500. The Center has established an accrued liability for this cost charged ratably over the term of the lease at the rate of \$187.50 per month. The accrued liability balance on December 31, 2009 was \$2,063. The lease was modified on February 9, 2009 to add an early termination clause. The clause requires the Center pay an extra month's rent of \$1,200 to break the lease with 30 days notice with no impact on the deposit.

The Board of Directors has evaluated growing demand for the Center's services and has authorized the Executive Director to explore and enter into negotiations for a new location, providing suitable space might be found at a satisfactory price. It is expected that the earliest date on which the Center might relocate would be June 2010. Since the feasibility of these plans remained uncertain on December 31, 2009, the financial statements do not reflect costs of a potential relocation or termination of the lease.

**NOTE E—CONCENTRATION OF RISK**

The organization is highly dependent on charitable contributions and grants from donors in the middle Tennessee area. If economic conditions worsen or culture changes occur in the service area these funding sources might decrease extensively and the organization would experience serious difficulty in continuing operations.
